Guidelines

- ◇ Adults 18 years and older are eligible.
- ◇ Entries must be original and created within the last 2 years. No kits / computer-generated art.
- ◇ No pieces previously entered in an Arts by the Shore Show may be submitted.
- ◇ 2 Dimensional work must be no larger than 35" x 42", including frame and mat, securely framed and wired, ready to be hung—**no exceptions**. No saw tooth hangers.
- ◇ Construction design artwork must not be larger than 54" x 75" (a double size quilt) or heavier than 50 pounds.
- ◇ No artwork may be removed before the show is over, and no artwork may be left in the building after the show ends.
- ◇ An artist may enter 3 pieces in each of the 2 main divisions, 2 dimensional and constructive design

Registration and Fees

Pre-registration: \$10 for 3 pieces

Sandy Nelson studied Fine Art and painting at the University of KY and the Scottsdale Art School. Her portraits and landscapes have won many national awards from Maine to California,. Her work is included in over 60 corporate and museum collections, including George Steinbrenner, owner of the NY Yankees. Nelson's works are included in two 2011 books, "Best of America/Oil Artists" and "100 Southern Artists".

"My influences are as diverse as the great Spanish, Russian, and French impressionists to a childhood amid the dark hills of eastern Kentucky. In the latter I found a sincere appreciation for the beauty of the world around me, in the former, inspiration to express it. My work is not edgy nor avant-garde; it doesn't follow fads or trends-- it is simply truth as I perceive it."
